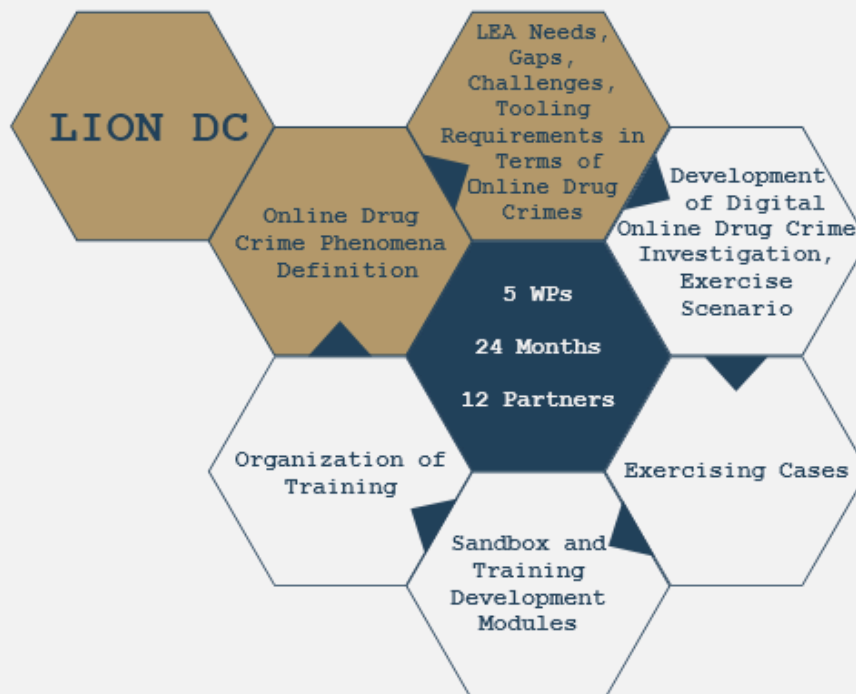

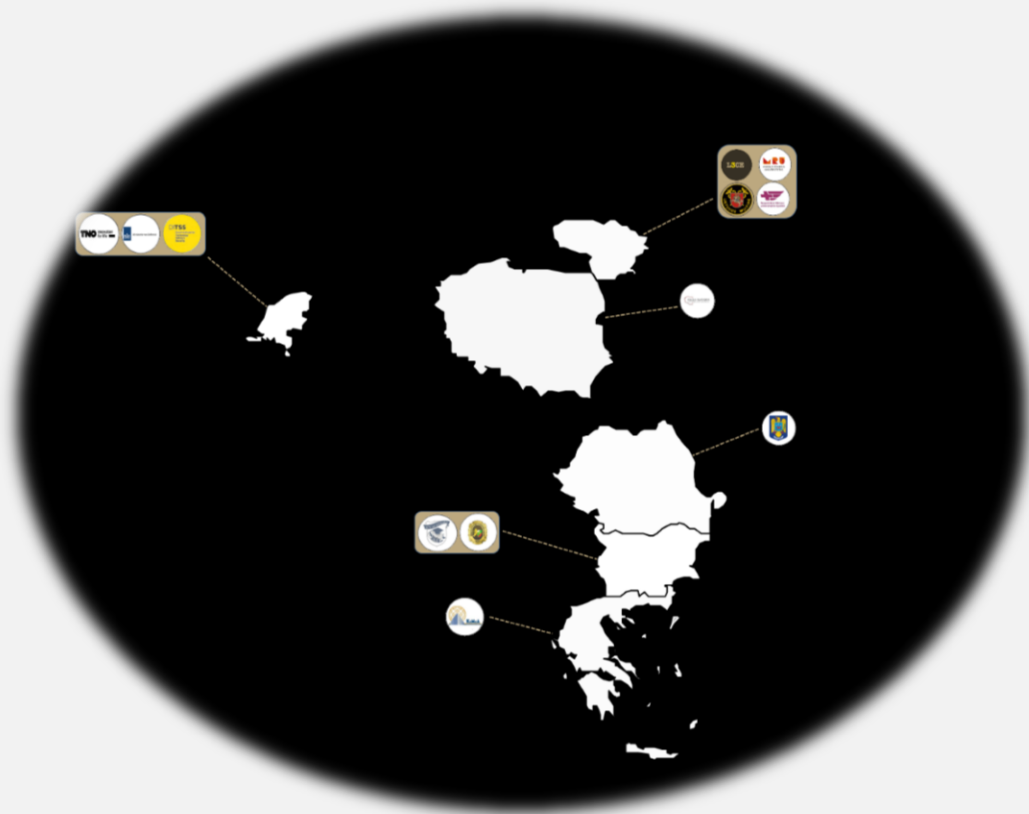

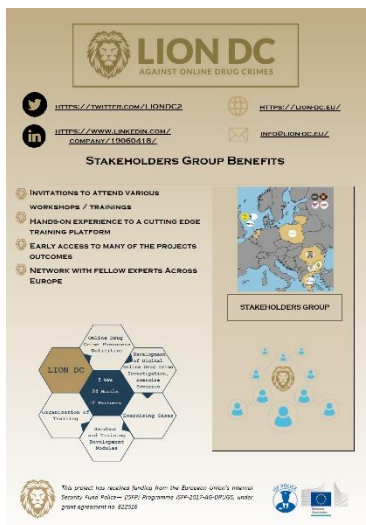


# STAKEHOLDERS GROUP

## BRIEFLY

The stakeholder group is an auxiliary body of LION DC project, targeting to provide regular and meaningful input and ensure that the project objectives are broadly understood. The second objective of this board is to support and alleviate planning and execution of project activities, including trainings and to disseminate further the results in the project's duration. It will be mainly formed by LEAs and members of different networks (ENLETS, SENTER) that are not directly involved in the LION DC consortium. This group has a very specific role regarding its activities during the project duration. These activities will be conducted by invitation of the members to dedicated project meetings and their involvement in the dedicated LION DC events (e.g. workshops, trainings, etc.).

## STAKEHOLDERS GROUP BENEFITS



To better communicate and inform the interested audience about the benefits that a SG member could gain, LION DC consortium distributed one-page informative flyer to project's social media and website.

## CURRENT SG MEMBERS

Reaching the first year of the project's lifetime, external to the consortium practitioners and experts have shown huge interest in LION DC initiative. At the time being, 20 members from 5 different organizations (national cybercrime units & academia) compose the Stakeholders Group.







## WP2 IN A NUTSHELL...

### WP2 OVERVIEW

*The Polish Platform for Homeland Security (PPHS) - the leader of Work Package 2 (WP2) "Online Drug Crime Phenomena Definition & LEA needs assessment" - was responsible for collecting data and analyzing the online drug crimes phenomena from the perspective of the Law Enforcement Agencies represented in the consortium. The activities of WP2 are successfully completed and the results are passed for further implementation in other Work Packages and activities.*

*WP2 tasks identified common needs/ gaps of LEA (skills/trainings, procedures and legislation, tools) and challenges as the main challenges they deal with. One part of the work focused on the technologies currently used in online drug cases and resulted in determination of the technological needs and challenges faced by the agencies that oversee security. As a result of WP2, a database was also created containing almost 100 useful Digital Online Drug Crimes Investigation tools (commercial and free solutions). At the end of the WP2, two practical exercise scenarios were created for further use in WP3 and WP4. The task ended with a summary of LEA's expectations of improvements to the Digital Online Drug Investigation and the success factors of the LION DC project.*

*During the WP2, the following reports have been prepared:*

- *"LEA Digital Online Drug Crimes Investigation Needs Survey Report";*
- *"Digital Online Drug Crimes Investigation tooling requirements" consisting of Digital Online Drug Crimes Investigation tooling questionnaire and Digital Online Drug Crimes Investigation tooling LEA challenges;*
- *"Detailed specification of 2 Digital Online Drug Crimes Investigation exercise scenario";*
- *"Digital Online Drug Crimes Investigation improvements expectations and success factors".*

*The aforementioned reports were based on information obtained from representatives of Law Enforcement Agencies – partners of the LION DC consortium.*

*In the context of WP2, two international meetings were held. It was an opportunity to conduct a thorough discussion concerning the fight against online drug trafficking. The first meeting was held on February 27-28, 2019 at the Regional Police Headquarters in Poznan (Poland). The main objective of the meeting was to identify the common needs of the agencies that fight against online drug crimes (cybercrime units, drugs divisions etc.). The second meeting was held on April 17-18, 2019 in Leiden (the Netherlands). Its main goal was to discuss the different challenges that LEAs representatives face, when conducting investigations connected with online drug crimes. Moreover, in September 2019, the 3rd LION DC project workshop took place in Vilnius, Lithuania, where the final findings of Work Package 2 were summarized and presented among LION DC Consortium partners.*





## CLUSTERING ACTIVITIES

### LINKAGE WITH OTHER PROJECTS/ NETWORKS

According to LION DC's Dissemination and Communication strategy, the consortium has established initial links and communication channels with i-LEAD and ANITA projects to maximize their impact through their audience, for knowledge sharing, exchange of best practices, stakeholders feedback and other respective activities, based on the common ground identified as described below in detail.

i-LEAD aims to build a sustainable & permanent Pan European Network of Law enforcement Agencies, is one of the EU projects that LION DC consortium would be glad to cooperate with. i-LEAD and LION DC share the same principles on supporting LEA community, each project from its own perspective; furthermore, LION DC aims to create functioning Online Drugs investigation community, comprised of practitioners, and participants from academia by extending SENTER, ENTER and i-LEAD initiatives.

Concerning ANITA, it is an EU funded project that aims to boost the LEA's investigation process and to significantly increase their operational capabilities, by introducing a set of innovative tools for efficiently addressing online illegal trafficking challenges. Moreover, it aims to facilitate the novice officers training process and to optimize the learning curve.

Furthermore, LION DC stand banner was placed in the exhibition area where presentations of the most advanced EU research projects took place: TITANIUM, ASGARD, RAMSES.*

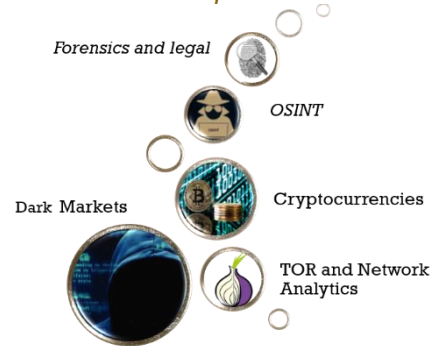
Delegates of LION DC project took part in the joint workshop "**Workshop on fighting crime with focus to drugs and people trafficking**", organized by MEDEA project, introducing and elaborating with other practitioners on the drug trafficking problem and the possible countermeasures. The scope of the workshop was on drug trafficking and overall the discussions were fruitful, since experts from various fields joined forces. The workshop's outcomes will be used as input for the upcoming activities of LION DC.



# UPCOMING TRAININGS

## UPCOMING TRAINING WORKSHOPS FOR TEAM LEADERS & PRACTITIONERS

*Within the LION DC project two trainings – one aiming at operational training and the other at managerial training - will be developed based on scientific research and LEA practitioners' inputs from multiple countries. The first one -the 'management' training is scheduled to take place in Krakow during mid-February 2020.*



### **LION DC "Management" training**

*The LION DC 'management' training will take place on 12-14 February 2020 in Krakow, Poland. The training focuses on increasing the awareness and understanding of the latest trends in online drug criminality. Topics as dark web and cryptocurrencies are trained in a practical and interactive setting. This hands-on focus improves the understanding and comprehension of the challenges that LEA's face in fighting online drug criminality.*

*The training will span 2,5 days and is aimed at non-executive law enforcement personnel such as team leaders, who do not have field experience on the topic of online drug trade.*

### **LION DC "Practitioners" training**

*The LION DC 'practitioners' training will be held in the Netherlands during April-May 2020. It focuses on tactical police officers. The training spans 4 days and is a combination of theory and practice. The training will go in-depth into the latest trends and technologies, such as cryptocurrency-analytics and tooling.*

*LION DC offers the opportunity to stakeholders, partners and interested LEA officials to participate in the project by attending trial training sessions. Attending LION DC trial training sessions will offer early access to the material developed in the project and includes a waiver of any fee. On top of that trainees will have access to the training material afterwards.*
